### **Abstrak**

It means: *Allah does not forbid you to do good and be fair to those who do not fight you in matters of religion and do not expel you from your hometown. Indeed, Allah loves those who act justly.*(Agung, 2023)

A shared commitment between religious scholars, the government, education, and the community is key to this strategy's success.
